**These competition specifications for Bowls Mid Canterbury fixtures apply to all players and clubs participating in Sub Centre competitions and events.**

**The Match Committee reserves the right to alter these competition specifications during the season in any way it sees necessary to ensure the completion of competition events. Any changes will be notified to all clubs prior to closing dates for entries to competitions.**

### Enquiries

- Please remember that the Match Committee Convenor works on a voluntary basis and operates around other commitments. Please be patient, & leave a message on phone when appropriate, so that you can be contacted when the Convenor is available.

### Suggestions or Submissions for Consideration for Next Season

The Sub Centre Executive and the Match committee are always interested in constructive ideas for future seasons. Please submit any such suggestions in writing to the Match Committee Convenor at the end of the season and prior to the Annual General Meeting of the Sub Centre.

### Laws and Regulations

All competitions will be played in accordance with the **Laws of the Sports of Bowls**, Crystal Mark Fourth Edition effective from 1<sup>st</sup> April 2023 & Bowls New Zealand regulations as applicable.

### Adhesive markings

If adhesive discs are used, all bowls belonging to players within a team or side should have the same **design and colour** adhesive markings.

### Cancellations

The Match Committee Convenor, or Tournament Manager, will advise Clubs/Players entered in a competition/fixture if the competition/fixture is postponed or cancelled.

### **Inclement Weather**

- **For Sub Centre events all players should report to greens as scheduled.**
- **Play in Sub Centre competitions may be subject to a delayed start in preference to either postponement or cancellation**
- **The Sub Centre Match Convenor, or their appointed representative, shall be responsible for decisions on the start of play, postponement, or cancellation of events.**
- **The Sub Centre Match Convenor will consult with green keepers at scheduled venues regarding the use of the greens whenever an event is affected by inclement weather.**

### Cell Phones

The use of cell phones is not permitted by players on or alongside the greens during play. It is preferred that all cell phones are switched off or are on silent during play.

## Draws

Draws for all Competitions and Tournaments will be published on the Bowlsworld website in the week before the competition is due to be held. In addition to this clubs will also be emailed a copy of draws.

## Sub Centre Titles

The following events qualify for a Sub Centre title:

- Senior Champion of Champion events
- Men's Open Singles – J Lowry Cup
- Women's Open Singes – Nan Marsh Trophy
- Sub Centre Club Pairs
- Sub Centre Triples

Players winning a total of five Sub Centre titles will qualify for the award of a Sub Centre Star.

**Note:** Junior events do not qualify for a Sub Centre title but will qualify for a Junior Star award.

## Dress Code

The dress code for all Sub Centre fixtures and events is Whites or Club Uniforms, unless otherwise stated on entry forms.

## Controlling Body

The controlling body for Sub Centre events is the Bowls Mid Canterbury Sub Centre Match Committee. The controlling body will have the right to alter, add to, or delete any conditions of play due to unfavourable weather and/or special conditions to enable the completion of a competition/fixture. Each competition /fixture will be under the control of a Tournament Manager appointed by the Match Committee.

## Entries

- All entries must be submitted through Club Secretary (or club appointee). Entries should be completed on the forms provided in this booklet and must contain full details as required on the form.
- **Entries are to be in the hands of the Sub Centre Match Convenor by the specified closing date and time.**
- Any entry submitted in an incomplete format (e.g., without names of team members) may not be accepted.
- Interclub and Champion of Champion event entry fees will be invoiced to clubs by the Sub Centre Treasurer. Individual event entry fees are to be paid by entrants as indicated on entry forms.
- Late entries are accepted only at the discretion of the Sub Centre Match Committee.
- Any withdrawal of a player or team from a competition must be notified to the Match Convenor.

## Plural Membership

A player, who is a full-playing member of more than one club in the Sub Centre, can now play for any club she/he is a member of in any competition.

Plural members can play in any one discipline at one club only. E.g., they can only play Singles at **One** club, there is no restriction on them playing singles at one club and pairs at another, or any combination of disciplines as required so long as they play each discipline at **One** club only—note also that this rule shall apply to substitutions.

## Score Cards

- The skip shall be responsible for the scorecard in all disciplines.
- The scorecard must be completed **clearly and in full** for every game.
- The names of all players and the time the game finished must be entered, and the scorecard must be signed by both skips.
- A completed and signed score card shall be the official and final record of any game or match.

## Results

Recorders will be provided with appropriate cards/sheets/forms to complete for each competition round. Instructions will be given with appropriate forms and should be followed. It is important that the results are accurate. All teams should send in results regardless of home or away, win or lose.

## Umpires

Umpires are organised for each Sub Centre competition held at Club Greens in consultation with the Mid Canterbury Bowling Umpires Association. Clubs must provide an umpire or a competent neutral person to officiate on Interclub days.

Clubs are encouraged to ensure that they have at least one qualified Umpire in their membership, and more if possible.

## Substitutes Players.

**A Substitute is a player who is either temporary or permanently replacing an absentee member during a game or tournament.**

**Substitutes shall be permitted in accordance with the Laws of the Sport of Bowls (Crystal Mark 4<sup>th</sup> Edition April 2023), and Bowls New Zealand Regulations.**

- For Champion of Champion Events clubs wishing to apply to use a substitute player must do so in writing on the approved form as contained in this booklet.
- Application for a substitute player should be made as soon as the need for Substitute is known and must be in the hands of the Match Committee no later than one hour before play is due to commence. Clubs may phone the Tournament Convenor in advance of an event to notify the intention to present a Substitute player application before the start of play in an event.
- Applications from Clubs will be considered for the following reasons: accident, illness, family bereavement & work commitments. Other individual exceptional circumstances may be considered for approval at the discretion of the controlling body but must be consistent with Bowls NZ regulations.
- The Match Committee, as the Controlling Body for Champion of Champion Events, will decide on the eligibility of any substitute player before the commencement of a competition, and notify the Club/Player of their decision.
- Failure to provide a written application for a substitute player as required before the start of any competition commencing will result in disqualification from participation in that competition.
- Where a player qualifies for a National/Centre event that is scheduled to be played on the same day, a Substitute player shall be allowed, except for Singles events.

## Trial Ends

Before the scheduled start of play in any game, or before continuing an unfinished game on another day, one trial end may be played in each direction.

Trial ends must be completed not less than 5 minutes before the scheduled start of play.

Refer to Law 5.1 in Laws of the Sport of Bowls, Crystal Mark 4<sup>th</sup> Edition April 2023.

Club Controlling Bodies may arrange play in all Club Championships as they desire for the number of shots in Singles or ends in Pairs, Triples & Fours. Qualification for entry is that in Club Championships either open or drawn entries qualify, any members may form a pair, triple or a four.

- The Team members who win the Club Championship must be the members who are nominated and entered in the Sub Centre Champion of Champion Competition.
- Any change in playing personnel shall be subject to the prior approval of the Sub Centre Controlling Body and shall be limited to one substitute player, in accordance with Law 33 and Bowls New Zealand Regulation 7.

The Club entry must be competition based unless a club has insufficient members to hold a competition.

- Where a club has insufficient members to hold a competition, and sufficient players to make up a team, the club may nominate the members to make up their Champion of Champion competition entry.

### General Conditions (Men and Women) for ALL Champion of Champion events:

- Where a game is of a fixed number of ends, in the event of a tie, an extra end or ends shall be played to decide the winner.
- No time limit.
- Byes will be disposed of in the first round.

### Junior Events:

- Junior Events are for players who have been full members of a club and are in their 5<sup>th</sup> playing year or less.
- Where a Club has sufficient **registered** players that qualify as Junior's to enable a competition to be played, a competition **must** be played to make an entry into Champion of Champion events.
- Where a Club has **insufficient** registered players that qualify as Junior's to enable a competition to be played, the Club may **nominate** players to make up a team for entry into a Champion of Champion event.
- Where a club has only one qualifying Colt/Junior player the club may nominate this player for entry into the Sub Centre Champion of Champion Colts and/or Junior Singles event.
- The Colts Singles event is open to players of both genders. Where there are insufficient entries to hold separate male and female events, the competition shall be played as one event including both male and female players in one draw.

## General Information

- Hefford Shield has been contested in Mid Canterbury for over 50 years. The purpose of the competition is to involve as many players as possible from each Club. It is an opportunity for new Players to play interclub.
- The competition is a Round Robin format.
- Each Club may enter one team. One round in the morning and one round in the afternoon. Each Club needs to arrange different teams to play in each round.
- Where Clubs have insufficient players for different teams in each round, a change of 1 player per team is allowed for each round.
- The Hefford Shield this season will be a **triples** competition.

## Conditions of Play:

- 18 completed ends.
- Wins, Draws, and then points differential to decide the overall winner.
- If the jack is incorrectly delivered, the opposing skip may place the jack in a legal position and the mat may be moved.
- If an end is killed or declared dead, it is to be replayed.
- In the event of a Tie, the Match Committee will have the discretion to find a winner by whatever means necessary.
- Match Committee will supply cards.
- Umpires to be arranged by Match Committee in consultation with Umpires Association.
- Host Club to arrange rinks required etc with their Greenkeeper & Morning and Afternoon Tea on the run, players pay refreshment fees as required to host Club.
- Smaller clubs may combine their available players with other clubs to make up teams.
- Cancellations or postponements will be advised to each Club by the Match Committee by 8.00 am on the day of play.
- Clubs must complete the attached entry form for the competition.
